

**CONTRACT AMENDMENT NO. 6
CONTRACT FOR TEMPORARY WORKER SERVICES
CONTRACT # SPB12-2029P-1**

This CONTRACT AMENDMENT No. 6 is to amend the above-referenced contract between the State of Montana, Department of Administration, State Procurement Bureau (STATE), whose address and phone number are Room 165 Mitchell Building, 125 N Roberts, PO Box 200135, Helena MT 59620-0135, (406) 444-2575 and Brady Co. Inc, dba A2Z Staffing Solutions (CONTRACTOR), whose address and phone number are 1824 N. Last Chance Gulch, 2nd Floor, Helena, MT 59601, (406) 443-7664.

The STATE and CONTRACTOR desire to amend Contract #SPB12-2029P-3 as follows:

- 1) In accordance with the section entitled Effective Date, Duration, and Renewal, both parties mutually agree to extend this Contract for the period May 1, 2017, through April 30, 2018, per the terms, conditions, and prices agreed upon. This is the seventh (final) year of the Contract.
- 2) Section 7.1, Consideration/Payment, is amended to: (old language interlined, new language underlined) replace set cost per hour fees with a fully loaded labor billing rate of 1.4, (i.e. employee fully loaded hourly pay rate multiplied by 1.4 equals total paid by the agency). Fully loaded labor rate includes the employee's salary plus tax, insurance, and benefits withholding. Agency bill rate equals the employee pay rate multiplied by 1.4. Taxes, insurance, benefits and all other Contractor expenses are included in the agency bill rate. Contractor may not bill State for any other expenses.

Except as modified above, all other terms and conditions of Contract SPB12-2029P-1 remain unchanged.


